

#### **ORDINANCE NO. 3351**

AN ORDINANCE INCLUDING AND INCORPORATING CERTAIN LAND WITHIN THE LIMITS AND BOUNDARIES OF THE CITY OF ABILENE, KANSAS.

Be it Ordained by the Governing Body of the City of Abilene, Kansas, that:

Section 1: The land legally described herein, meeting one or more of the conditions for annexation as prescribed by K.S.A. 12-520, is hereby included and brought within the corporate limits of the City of Abilene, Kansas:

The East Half of the West Half of the Southeast Quarter (E½ W½ SE¼) of Section Seven (7), Township Thirteen (13) South, Range Two (2) East of the 6th P.M., Dickinson County, Kansas EXCEPT:

A tract of land in the East Half of the West Half of the Southeast Quarter of Section 7, Township 13 South, Range 2 East of the 6th P.M., described as follows: Beginning at the Northwest corner of said East Half of the West Half of said Southeast Quarter Section: First Course, thence on an assumed bearing of North 89°18'52" East, 201.967 meters (662.62 feet) along the North line of said Quarter Section to the East line of said West Half; Second Course, thence South 00°30'37" East, 18.749 meters (61.51 feet) along said East line: Third Course, thence South 87°22'31" West, 202.088 meters (663.02 feet) to the West line of said East Half of said West Half of the Southeast Quarter; Forth Course, thence North 00°32'44" West, 25.587 meters (83.95 feet) along said West line to the West line to the Point of Beginning.

Section 2: All provisions of law herein set out are hereby adopted by reference and the City Clerk shall file a certified copy of this ordinance, when effective, with the County Clerk, Register of Deeds, and Election Officer of Dickinson County, Kansas.


