


### Summary of Ordinance No. 3225

ORDINANCE NO. 3225

AN ORDINANCE APPROVING THE REZONING OF LAND FROM "R-3" GENERAL RESIDENTIAL DISTRICT TO "B-3" HIGHWAY BUSINESS DISTRICT; AMENDING THE CURRENT DISTRICT ZONING MAP; ALL TO THE CODE OF ORDINANCES OF THE CITY OF ABILENE, KANSAS.

BE IT ORDAINED by the Governing Body of the City of Abilene, Kansas:

SECTION 1. The District Zoning Map of the City of Abilene, Kansas, adopted by Ordinance No. 2796 with all amendments thereto, is hereby amended as follows:

The boundary of the "B-3" Highway Business District is hereby amended to include the following described real property:

**Lots One (1) through Sixteen (16); Block 8, and Lots One (1) through Twelve (12); Block 7, Central Park Addition to the City of Abilene.**

SECTION 2. A public hearing was conducted by the Planning Commission of the City of Abilene on January 8, 2013 and a recommendation was made to the Governing Body to approve the rezoning of the above referenced property.

SECTION 3. The District Zoning Map referred to in the Zoning Regulations Section 3, of the City of Abilene, Kansas, adopted by Ordinance No. 2796, as previously existing and amended, be and the same is hereby amended, to be consistent with the amendments set forth herein.
