

RESOLUTION NO. 051313-1

A RESOLUTION APPROVING ANNUAL APPOINTMENTS TO BOARDS AND COMMISSIONS OF THE CITY OF ABILENE, KANSAS

WHEREAS, Article 8 of Chapter 1 of the City Code of the City of Abilene establishes certain appointed boards and commissions for the City of Abilene, Kansas;

WHEREAS, the City of Abilene appoints members to said boards and commissions each year in May;

WHEREAS, serving on appointed boards and commissions provides members of the public to serve their community in a unique and appreciated manner.

NOW, THEREFORE BE IT RESOLVED, by the City Commission of the City of Abilene, as follows:

Section 1. Annual Appointments. That the following appointments are made to various boards and commissions of the City of Abilene, Kansas:

- Bruce Youtsey and Kyle Campbell to the Airport Advisory Committee with terms ending 2016;
- Marvin Ledy, Rance Biesecker, and Jill Crist to the Board of Zoning with terms ending 2016;
- Daryl Roney, Russ Wilkins, and William Wassink to the Economic Development Council with terms ending 2016;
- Velda Becker and Vangie Henry to the Heritage Commission with terms ending 2016;
- Braden Adams, Olivia Crist, Wyatt Davis, Thurman Geissing, Kendra Guy, Allison Liby, Maran Meneley, Shiann Olberding, and Jackson Welch to the Kids' Council with terms ending 2015;
- Marilyn Holt and Sarah Gieger to the Library Board with terms ending 2017;
- Katie Allen and Gene Bielfield to the Planning Commission with terms ending 2016;
- Mary Montgomery, Lisa Wright, and Mary Zey to the Sister City Committee with terms ending 2016;
- Christina Krause and Johnny Kinder to the Tree Board with terms ending 2016;

Section 2. Guidelines for Operations. Appointed boards and commissions shall follow the guidelines for appointed boards and commissions as defined by Section 1-813 and 1-814 of the City Code. The City Manager, or the designated staff representative, shall provide an orientation for new members of appointed boards and commissions.

Section 3. Recognition for Service. The City of Abilene wishes to recognize those who have served on its appointed boards and commissions that will not be continuing their service. The City Manager shall have prepared a Certificate of Service to be signed by the Mayor to be provided to each member resigning from their board or commission. The following citizens are hereby recognized for their contributions and service to the City of Abilene:

- Alli Hiatt, Allison Beswick, Madisyn Riffel, and Jessica Hayes from the Kids' Council; and



Section 5. Effective Date. That the effects of this Resolution shall be in full force after its approval by the City Commission.


