#### ORDINANCE NO. 18-3361

AN ORDINANCE AUTHORIZING THE EXECUTION OF AN ECONOMIC DEVELOPMENT INCENTIVE AGREEMENT BETWEEN THE CITY OF ABILENE, KANSAS AND GREAT PLAINS MANUFACTURING, INCORPORATED; AUTHORIZING THE EXECUTION OF OTHER DOCUMENTS RELATED THERETO; AND AUTHORIZING THE ISSUANCE OF BONDS TO FINANCE CERTAIN COSTS RELATED THERETO.

WHEREAS, the City of Abilene, Kansas (the "City") is a municipal corporation duly organized and validly existing under the laws of the State of Kansas as a city of the first class; and

WHEREAS, the City and Great Plains Manufacturing, Incorporated, a Kansas corporation (the "Developer") have negotiated the terms of an Economic Development Incentive Agreement, dated as of September 10, 2018 (the "Development Agreement") relating to the acquisition, furnishing and equipping of a manufacturing facility (the "Project") located in the City; and

WHEREAS, to facilitate the construction of the Project, the City has agreed under the terms of the Economic Development Incentive Agreement to design, engineer and construct street improvements; and

WHEREAS, the construction of the Project will stimulate and foster economic development in the City and its environs in order to enhance and provide for the general and economic development and welfare of the City and its citizens; and

WHEREAS, pursuant to the Constitution, particularly Article 12, Section 5 thereof, and statutes of the State of Kansas, particularly of K.S.A. 12-101 et seq., as amended (collectively, the "Home Rule Act"), the Governing Body hereby finds and determines that it is necessary and desirable and in the interest and for the general economic welfare of the City and its inhabitants, that the City (a) enter into the Development Agreement; and (b) authorize the issuance of bonds of the City, in one or more series, pursuant to the Home Rule Act, in an aggregate principal amount necessary to finance costs of designing and constructing the street improvements, all as described in and in the amounts set forth in the Economic Development Incentive Agreement, and related reserves and financing costs (the "Bonds"); and

WHEREAS, the Governing Body hereby further finds and determines that it is necessary and advisable and in the interest of the public health, safety and welfare, including economic development, of the City, to authorize by home rule ordinance the execution of the Economic Development Incentive Agreement and authorize the issuance of the Bonds to provide funds to pay the costs of the street improvements.

NOW, THEREFORE, BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF ABILENE, KANSAS:

- **Section 1. Economic Development.** The Governing Body hereby finds and determines that the Project will stimulate and foster economic development in the City and its environs in order to enhance and provide for the general and economic development and welfare of the City and its citizens.
- Section 2. Development Agreement. The Economic Development Incentive Agreement is hereby approved in substantially the form presented to the Governing Body. The Mayor or Vice Mayor of

the City is hereby authorized and directed to execute the Development Agreement and such other documents, certificates and instruments as may be necessary or desirable to carry out and comply with the intent of this Ordinance, with such alterations, changes or additions in the foregoing agreements, statements, instruments and other documents herein approved, authorized and confirmed which as may be approved by the City Manager and as are approved as to form by the City Attorney, and the execution or taking of such actions shall be conclusive evidence of such necessity or advisability. The City Clerk or any Deputy City Clerk is hereby authorized to attest to and affix the seal of the City to the Economic Development Incentive Agreement and such other documents, certificates and instruments as may be necessary or desirable to carry out and comply with the intent of this Ordinance.

Section 3. Financing Authorization. The Governing Body affirms its intention to issue and sell, pursuant to the Home Rule Act, the Bonds, to finance the City's obligations pursuant to the Economic Development Incentive Agreement. The Bonds may be issued to reimburse expenditures made on or after the date which is 60 days before the date of this Ordinance, pursuant to Treasury Regulation §1.150-2.

Section 4. Further Authority. The City shall, and the officers, employees and agents of the City, including Gilmore & Bell, P.C., the City's bond counsel, are hereby authorized and directed to, take such action, expend such funds and execute such other documents, certificates and instruments, as may be necessary or desirable to carry out and comply with the intent of this Ordinance and to carry out, comply with and perform the duties of the City with respect to the Economic Development Incentive Agreement.

Section 5. Effective Date. This Ordinance shall take effect and be in force from and after its passage and publication of a summary thereof one time in the official City newspaper.
